SEC. 4. UTILITIES AND WATER RESOURCE FACILITIES. 14 The addition of the Rim of the Valley Unit to the 15 National Recreation Area shall not affect the operation, maintenance, or modification of water resource facilities 16 17 or public utilities within the Rim of the Valley Unit, except that any utility or water resource facility activities in the 18 19 Rim of the Valley Unit shall be conducted in a manner 20 that reasonably avoids or reduces the impact of the activi-

ties on resources of the Rim of the Valley Unit.
