3 (2) DESCRIPTION OF LAND.—The parcel of
4 Federal land referred to in paragraph (1) is the ap-
5 proximately 16.09-acre parcel of land in Arlington,
6 Virginia, as depicted on the map entitled “Arlington
7 National Cemetery, Memorial Ave–NPS Parcel” and
8 dated February 11, 2019.

9 Beginning on page 2, strike line 19 and all that fol-
10 lows through page 3, line 2, and insert the following:

1 (2) DESCRIPTION OF LAND.—The parcel of
2 Federal land referred to in paragraph (1) is the ap-
3 proximately 1.04-acre parcel of land in Arlington,
4 Virginia, as depicted on the map entitled “Arlington
5 National Cemetery–Chaffee NPS Land Swap” and
6 dated October 31, 2018.

7 Beginning on page 3, strike line 23 and all that fol-
8 lows through page 4, line 9, and insert the following:

9 (3) MANAGEMENT OF PARCEL TRANSFERRED
10 TO SECRETARY OF THE ARMY.—

11 (A) IN GENERAL.—The parcel of Federal
12 land transferred to the Secretary of the Army
13 by section (a)(1) shall be administered by the
14 Secretary of the Army—

15 (i) as part of Arlington National Cem-
16 etery; and

17 (ii) in accordance with applicable law
18 (including regulations), including section
19 2409 of title 38, United States Code.

20 (B) WOMEN IN MILITARY SERVICE FOR
21 AMERICA MEMORIAL.—

22 (i) MEMORANDUM OF UNDER-
23 STANDING.—The Secretary of the Army
24 shall enter into a memorandum of under-

1 standing with the Women In Military Serv-
2 ice For America Memorial Foundation,
3 Inc., defining roles and responsibilities for
4 the shared responsibility and resources for
5 the operation and maintenance of the
6 Women In Military Service For America
7 Memorial and the surrounding grounds.

8 (ii) ALLOCATION OF FUNDS.—The
9 Secretary of the Army may allocate funds
10 to the Women In Military Service For
11 America Memorial Foundation, Inc., to
12 support the operation and maintenance of
13 the Women In Military Service For Amer-
14 ica Memorial.
