8	(1) In general.—Nothing in this Act, the es-
9	tablishment of the Monument, or the management of
10	the Monument creates a buffer zone outside of the
11	Monument.
12	(2) Activity or use outside monument.—
13	The fact that an activity or use can be seen, heard
14	or detected from within the Monument shall not pre-
15	clude the conduct of the activity or use outside of
16	the Monument.
