3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Utah State Parks Ad-
5	justment Act".
6	SEC. 2. CONVEYANCE OF CERTAIN FEDERAL LAND TO THE
7	STATE OF UTAH.
8	(a) Antelope Island State Park Convey-
9	ANCE.—Not later than 180 days after the date of enact-
10	ment of this Act, the Secretary of the Interior shall con-
11	vey, subject to valid existing rights, without consideration,

- 2 in this section as the "State"), for inclusion in Antelope
- 3 Island State Park, all right, title, and interest of the

1	Indian State Park, all right, title, and interest of the

17	(3) Water rights.—As a condition of the con-
18	veyance under paragraph (1), the Secretary of Agri-

20	rights held by the United States identified as 63-44,
21	63-1607, and 63-2817 in the water rights database
22	of the Utah State Engineer that provide water to
23	the Castle Rock Campground and the Belknap His-
24	toric Guard Station interpretive site.
25	(4) Survey.—

1	(A) IN GENERAL.—If determined by the
2	Secretary of Agriculture to be necessary, the
3	exact acreage and legal description of the Na-
4	tional Forest System land to be conveyed under
5	paragraph (1) shall be determined by a survey
6	approved by the Secretary of Agriculture.
7	(B) Costs.—As a condition of the convey-
8	ance under paragraph (1), the State shall pay
9	the reasonable survey costs associated with the
10	survey under subparagraph (A).
11	(5) Additional terms and conditions.—
12	The Secretary of Agriculture may enter into an
13	agreement with the State with respect to additional
14	terms and conditions applicable to the conveyance
15	under paragraph (1), including—
16	(A) the management and maintenance of
17	the Belknap Historic Guard Station interpretive
18	site;
19	(B) the use and maintenance of roads and
20	trails on the conveyed parcel of National Forest
21	System land;
22	(C) the continued use of permitted live-
23	stock grazing on the conveyed parcel of Na-
24	tional Forest System land;

1	(D) continued Forest Service access to,
2	and use and maintenance of, any water rights
3	retained by the United States in the area of the
4	conveyed parcel of National Forest System
5	land; and
6	(E) any other terms and conditions nec-
7	essary to clarify management and maintenance
8	of the parcel of National Forest System land
9	after the date of conveyance.
10	(d) Modifications to Maps.—For the purposes of
11	a conveyance required by this section, the Secretary of the
12	Interior or the Secretary of Agriculture, as applicable, may
13	make minor modifications to the applicable map described
14	in subsection (a), (b), or (c)(1)(A) , including changes re-
15	flecting any applicable surveys conducted under this sec-
16	tion.
17	(e) USE OF CONVEYED LAND.—
18	(1) In general.—The State shall use any
19	Federal land conveyed under this section for public
20	purposes, including parks, campgrounds, recreation,
21	and permitted livestock grazing.
22	(2) Reversionary interest.—If a parcel of
23	Federal land conveyed to the State under this sec-
24	tion ceases to be used for public purposes described
25	in paragraph (1), the parcel shall, at the discretion

1 of the Secretary of Agriculture or Secretary of the

2 Interior, as applicable, revert to the United States.
