The Committee on Energy and Natural Resources will hold a Business Meeting on **Thursday, March 30, 2017, at 10:00 am in Room SD-366 of the Dirksen Senate Office Building in Washington, D.C.** to consider the following items on the short list:

**Agenda Item 1:** S.35, a bill to transfer administrative jurisdiction over certain Bureau of Land Management land from the Secretary of the Interior to the Secretary of Veterans Affairs for inclusion in the Black Hills National Cemetery, and for other purposes, **with a joint staff amendment in the nature of a substitute (FLO 17261).**

**Agenda Item 2:** S.55/H.R. 46, to authorize the Secretary of the Interior to conduct a special resource study of Fort Ontario in the State of New York, **with a joint staff amendment in the nature of as substitute to S.55 (FLO 17230) and one to H.R.46 (FLO 17267).**

**Agenda Item 3:** S.97, a bill to enable civilian research and development of advanced nuclear energy technologies by private and public institutions, to expand theoretical and practical knowledge of nuclear physics, chemistry, and materials science, and for other purposes.

**Agenda Item 4:** S.99, a bill to require the Secretary of the Interior to study the suitability and feasibility of designating the President James K. Polk Home in Columbia, Tennessee, as a unit of the National Park System, and for other purposes.

**Agenda Item 5:** S.117, a bill to designate a mountain peak in the State of Montana as 'Alex Diekmann Peak,' **with a joint staff amendment (FLO 17231).**

standards to certain security or life safety alarms or surveillance systems, and for other purposes.

**Agenda Item 17:** S.226, a bill to exclude power supply circuits, drivers, and devices designed to be connected to, and power, light-emitting diodes or organic light-emitting diodes providing illumination or ceiling fans using direct current motors from energy conservation standards for external power supplies.

**Agenda Item 18:** S.239, a bill to amend the National Energy Conservation Policy Act to encourage the increased use of performance contracting in Federal facilities, and for other purposes.
